#### **COMMERCIAL PLAN REVIEW**

An apartment house of 3 dwelling units or more

A commercial building

A public building

Any other structures deemed necessary by the Community & Economic Development Department Director

## PLAN REVIEW TIMELINE

On average, expect 2-3 weeks for the initial plan review to be returned to you.

During the plan review process, the plans are forwarded to the Fire Department and may be forwarded to other pertinent reviewers for approval. When the reviewers have signed off on the project, the permit may be issued, however no building construction can begin until the permit is issued.

## WHAT'S NEXT

When the plans are returned to the city, you will be asked to have your architect or engineer respond to the items in the plan review to resolve any issues that do not meet the currently adopted code or are unclear.

### **INSPECTION TIMELINE**

24 hours' notice is required for all Inspections. Inspections requested after 3:00 PM will not be scheduled until the day following the next working day.

# RESIDENTIAL REQUIREMENTS

All items needing permits:

- -Accessory Structures
- -Pools
- -Fences
- -Decks
- -Additions
- -Basement Remodeling
- -Windows/Siding
- -Roofing

A site plan, declaration of construction value, and plans for projects are needed when a building permit application is submitted.

## **INSPECTIONS**

Inspections are required at the following times & require a 24-hour notice:

- -Footings
- -Mid-phase and Final Roof
- -Pier holes
- -Framing
- -Electrical, Plumbing and Mechanical
- -Final

# **REMINDERS**

A permit is not necessary for one-story detached accessory buildings used as tool and storage sheds, playhouses, and similar uses, with a size of **120 SQUARE FEET or less.** Any accessory building exceeding 120 square feet **requires** a permit.

# ACCESSORY BUILDING CONDITIONS

No accessory building shall be erected in any required front or side yard, and no detached accessory building shall be erected closer than five (5) feet to any other building. No accessory building shall cover more than 30% of the rear yard. Structures 120 sq. ft. or less and less than 10 feet tall shall be limited to one per lot, located behind the rear building line of the principal building, and be no closer than 5 feet from the rear or side property line. No permanent structures should be constructed within easements.

Any open off-street parking, loading areas, or drives shall be graded and paved with asphaltic or portland cement concrete pavement for accessory buildings over 120 square feet.

Requirements for buildings exceeding 120 sq. ft. are listed in the UDO on Page 4-4.

- \*\* Any work constructed without a permit is subject to penalties and condemnation.
- \*\* Any contracted trade work must be completed by a City of Lansing licensed contractor.

\*\* All general contractors and tradesman must obtain an occupational license
