

ORDINANCE NO. 761

AN ORDINANCE OF THE CITY OF LANSING AMENDING ARTICLE 4, SNOW EMERGENCY ROUTES, SECTION 15-404(a), OF THE CODE OF THE CITY OF LANSING, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LANSING, KANSAS, THAT ARTICLE 4, SECTION 15-404(a), OF THE CITY CODE SHALL READ:

SECTION 15-404: Establishment of Routes and Posting of Signs.

(a) The following streets are hereby established as emergency snow routes within the city:

North 8th Street and Connie Street west to 7-73 Highway.
